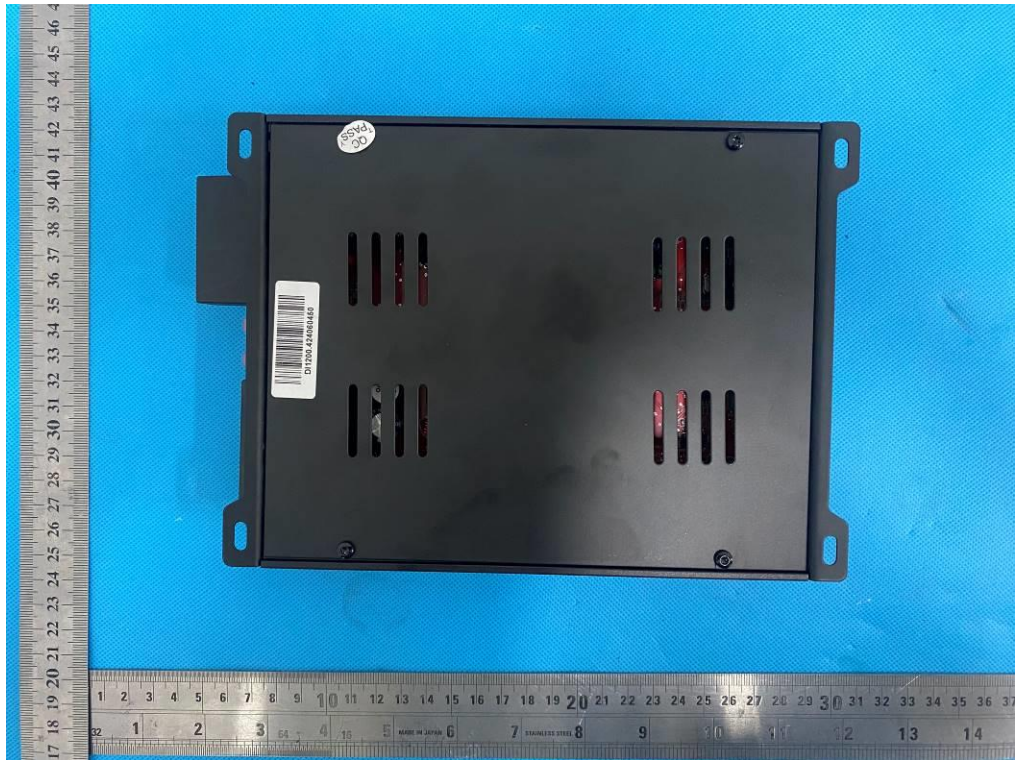

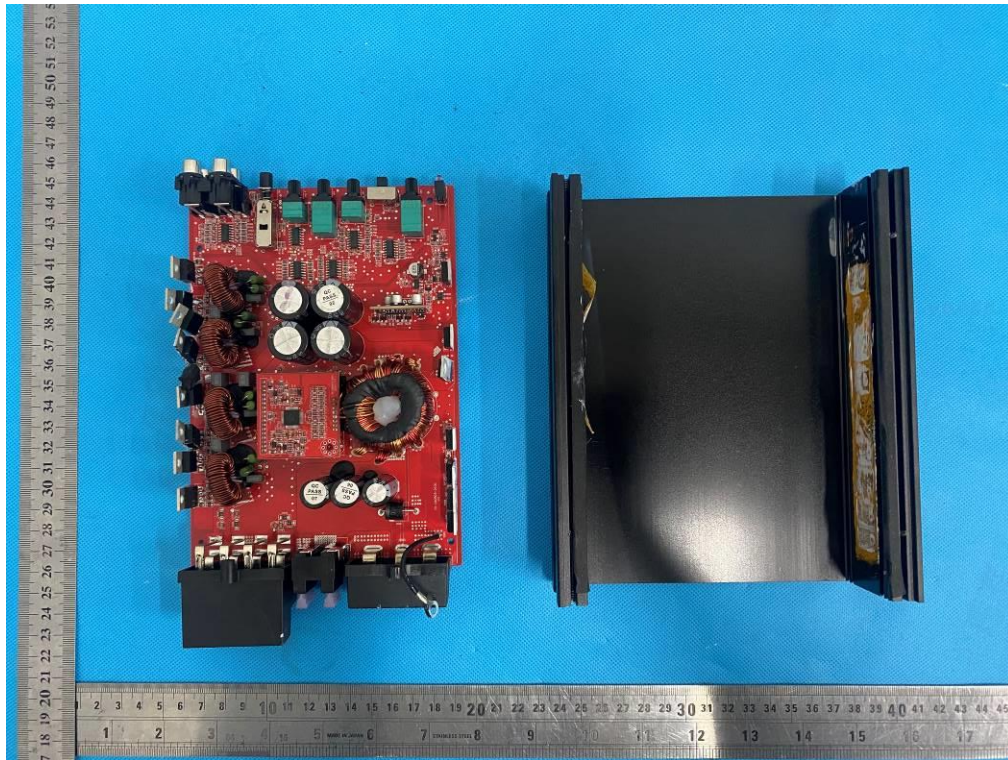
Port view-2 of EUT



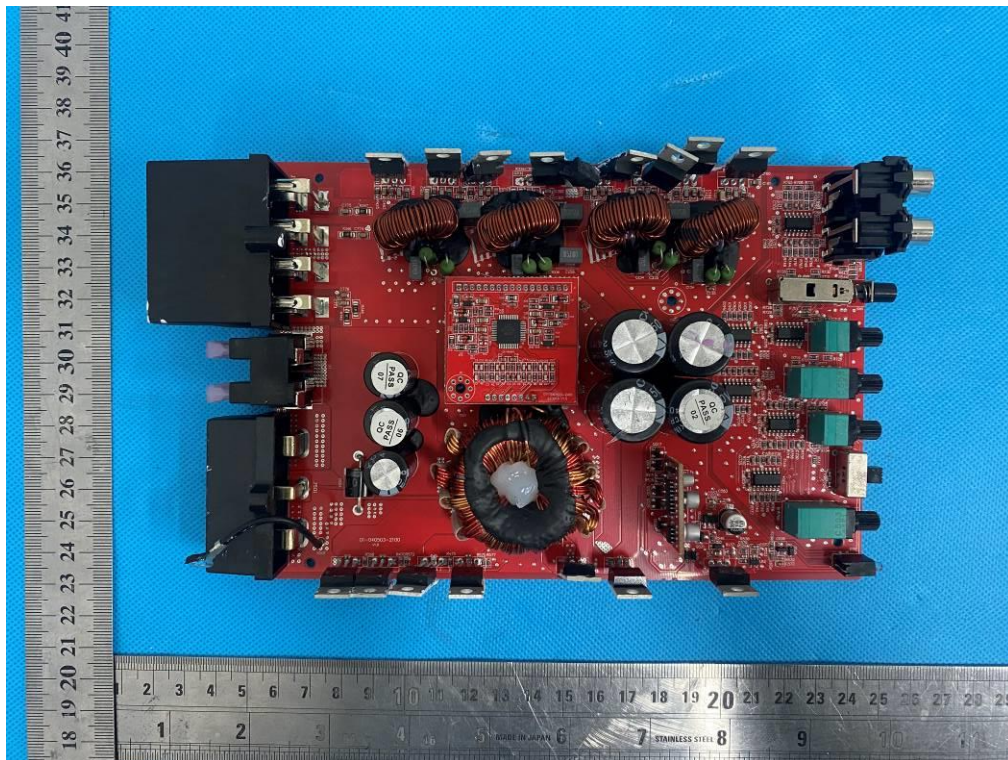

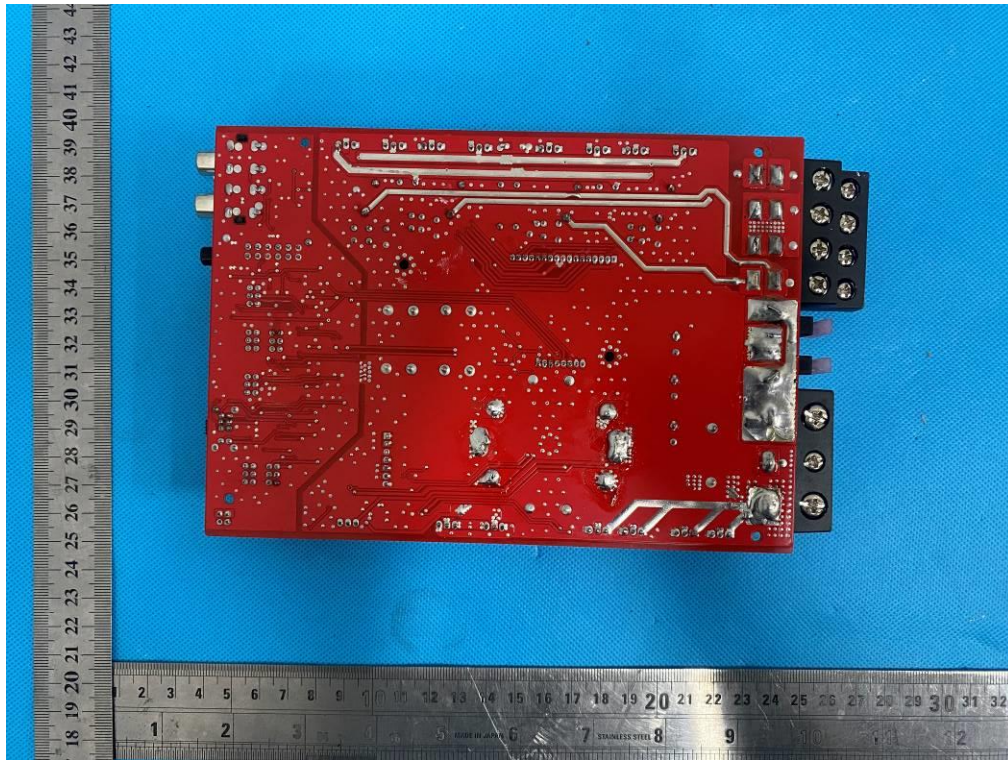
Open view-2 of EUT
