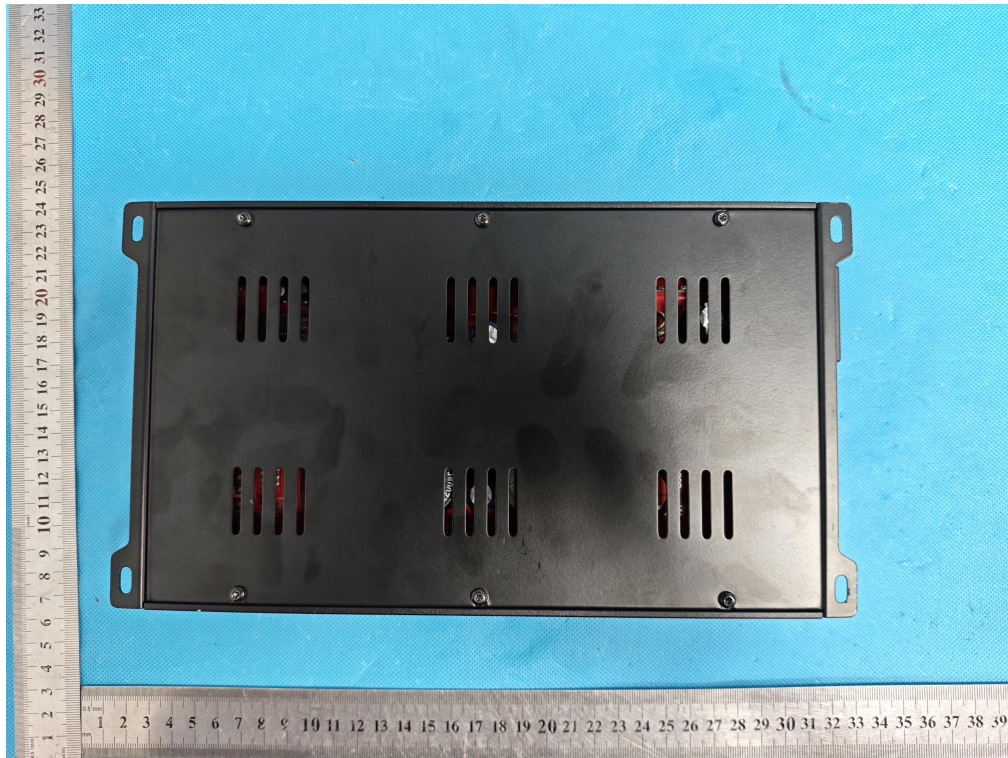


All view of EUT

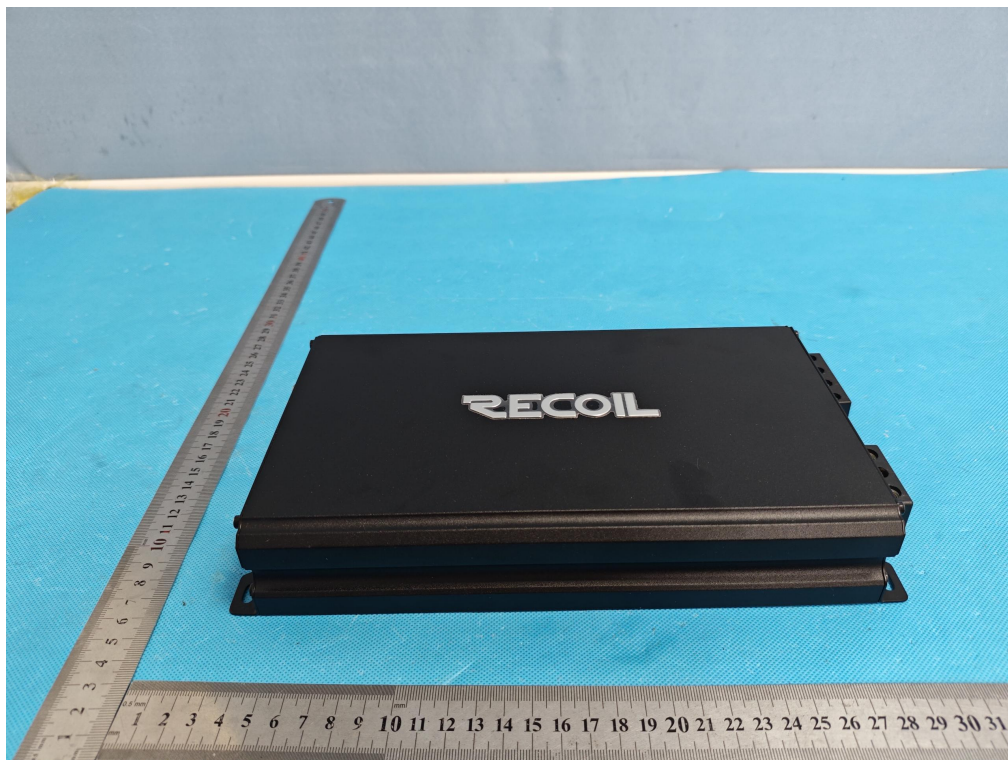


Top view of EUT

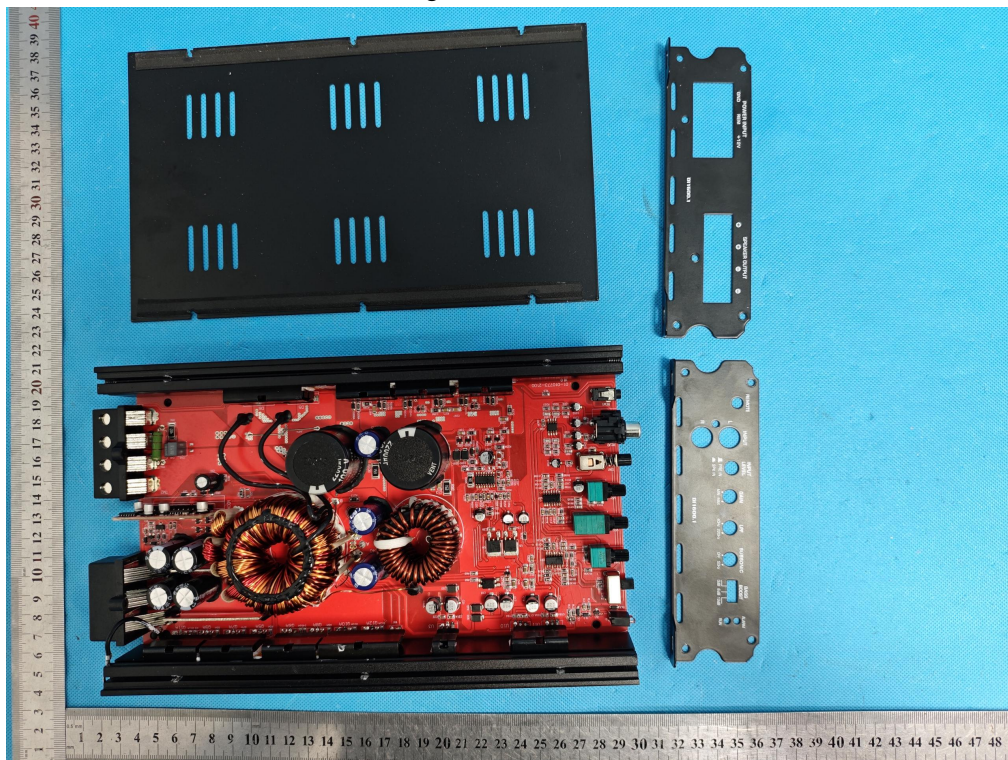


Left view of EUT

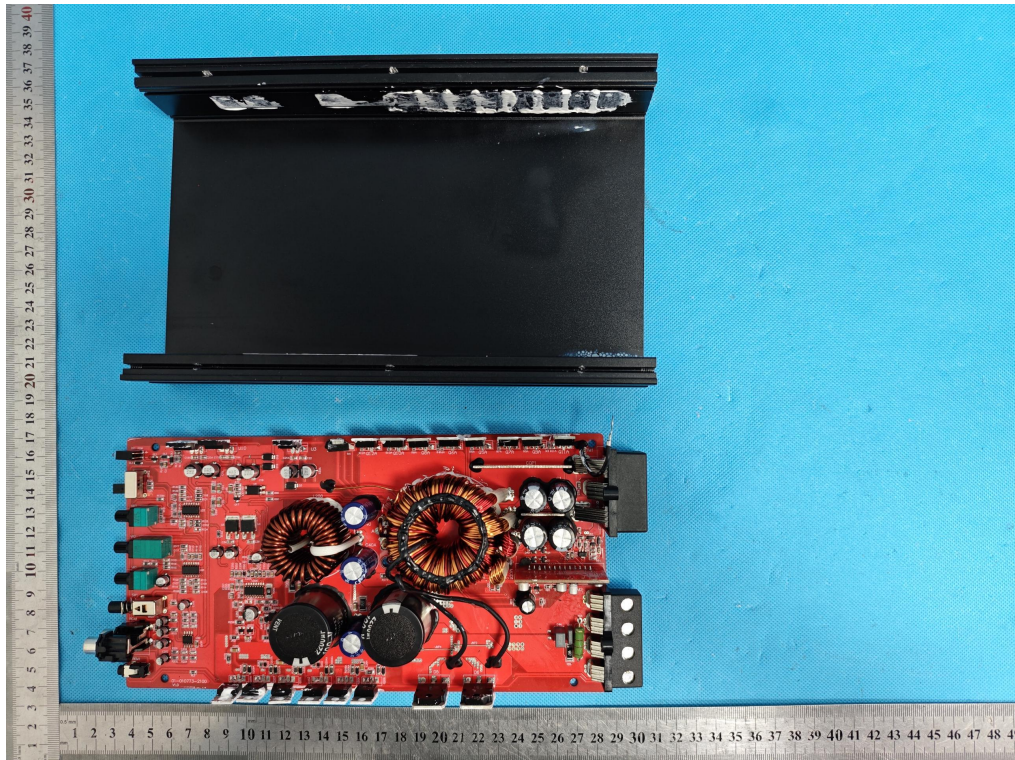


Right view of EUT

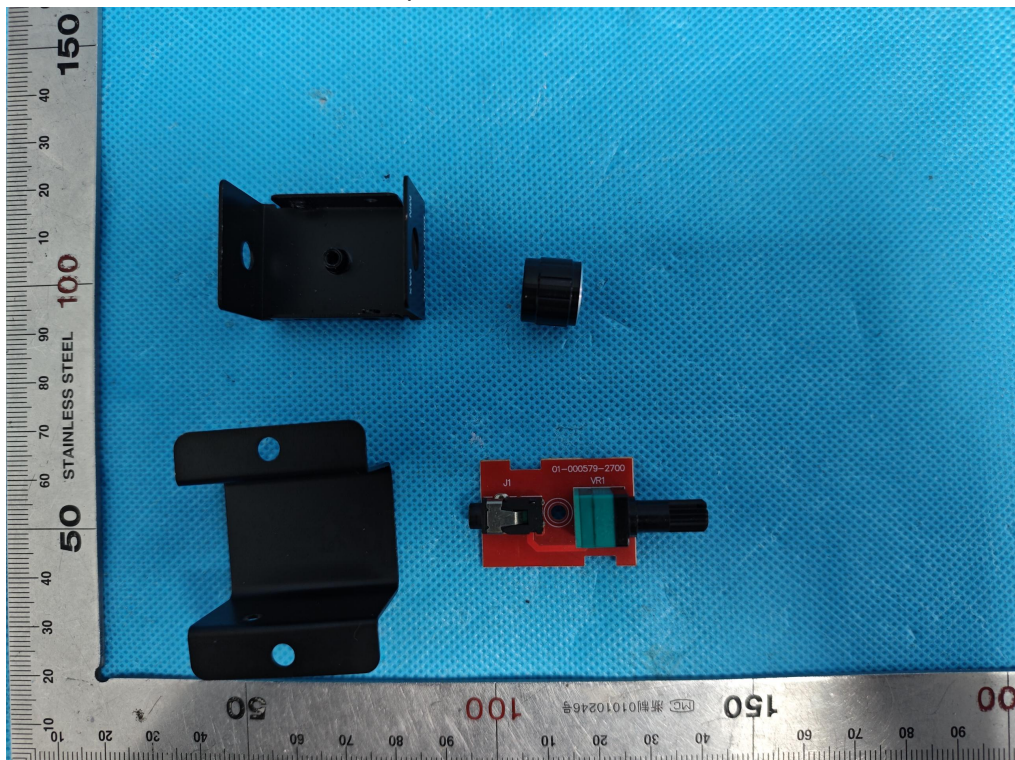


Open view-1 of EUT

Open view-2 of EUT



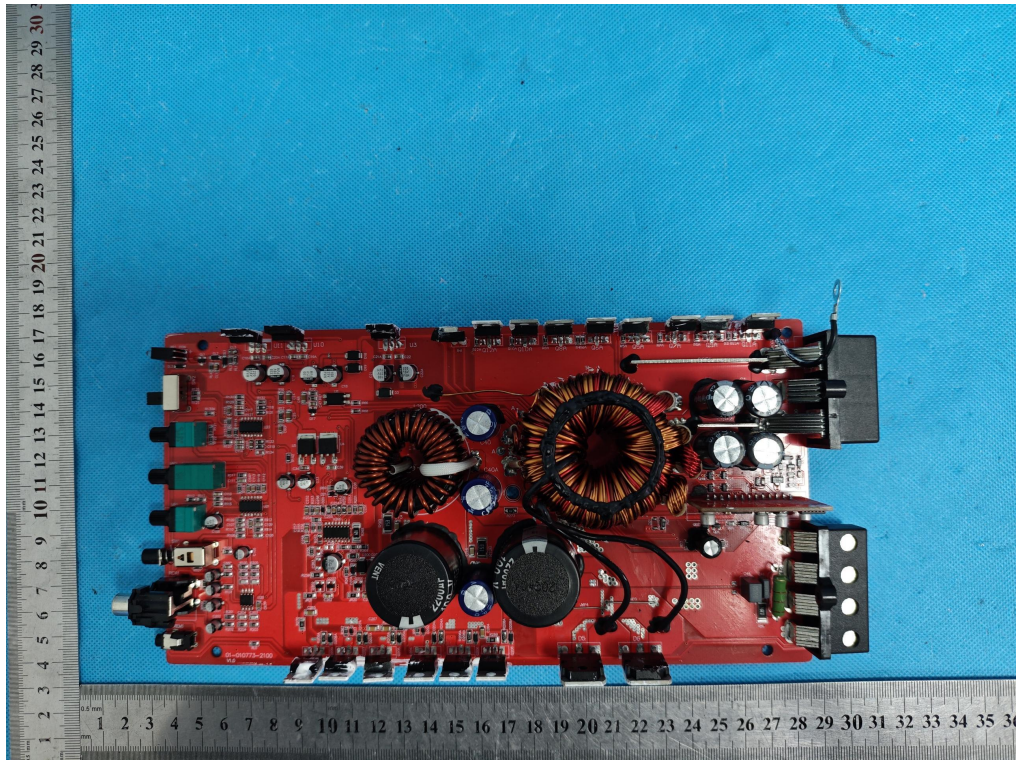

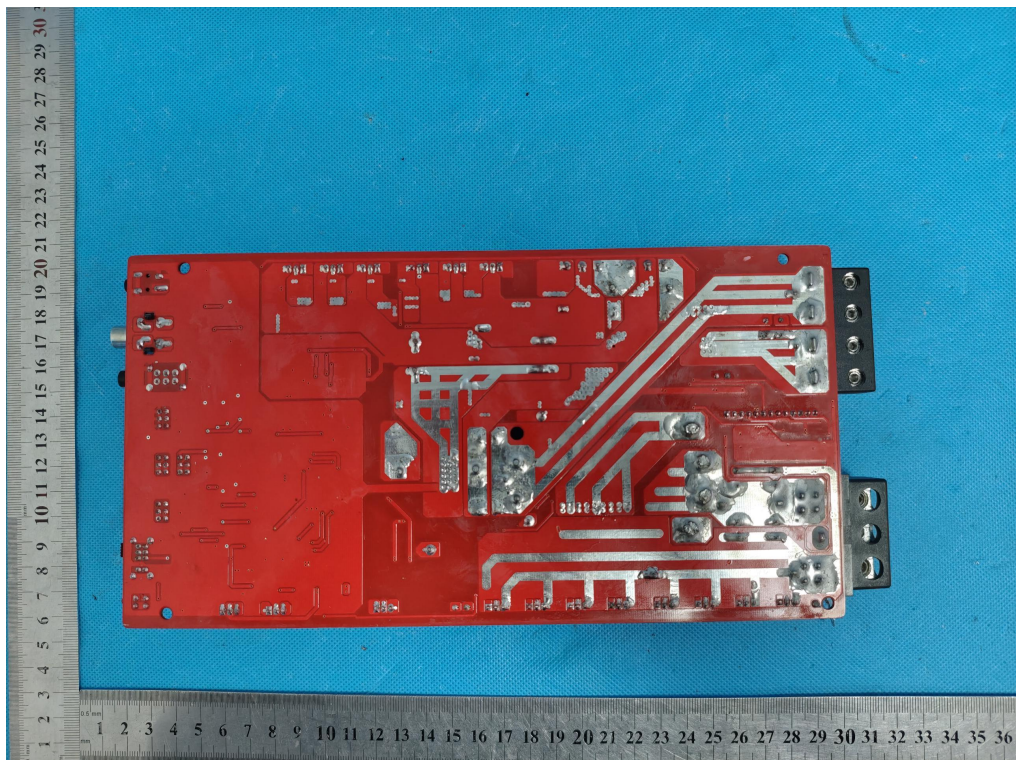

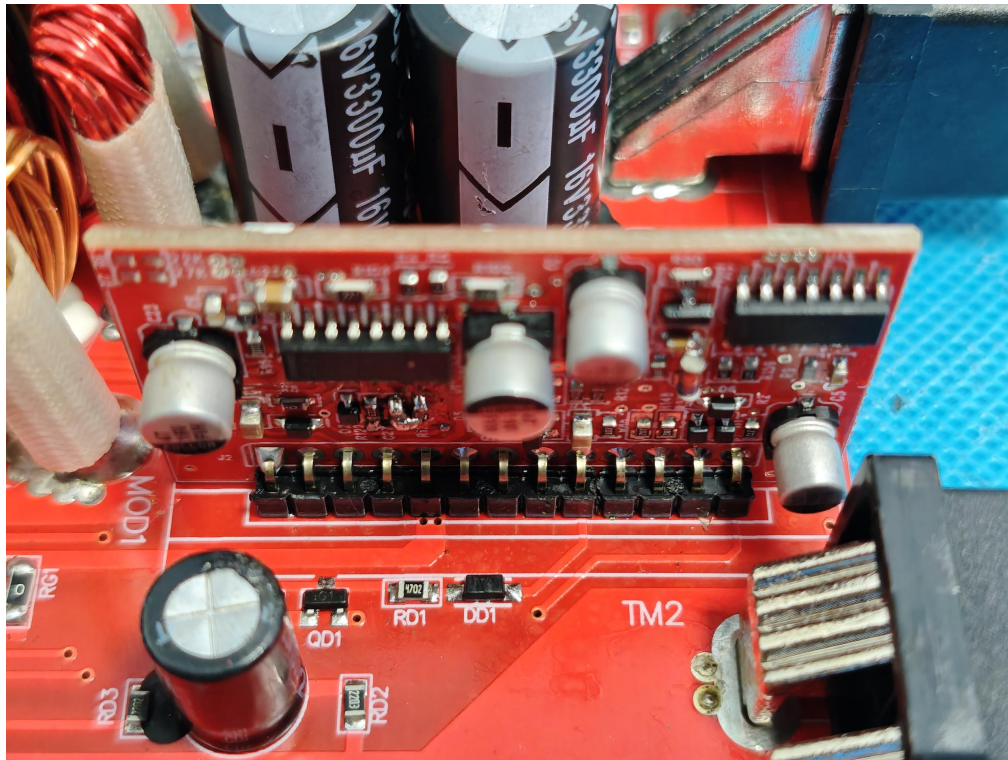


Internal view-1 of EUT

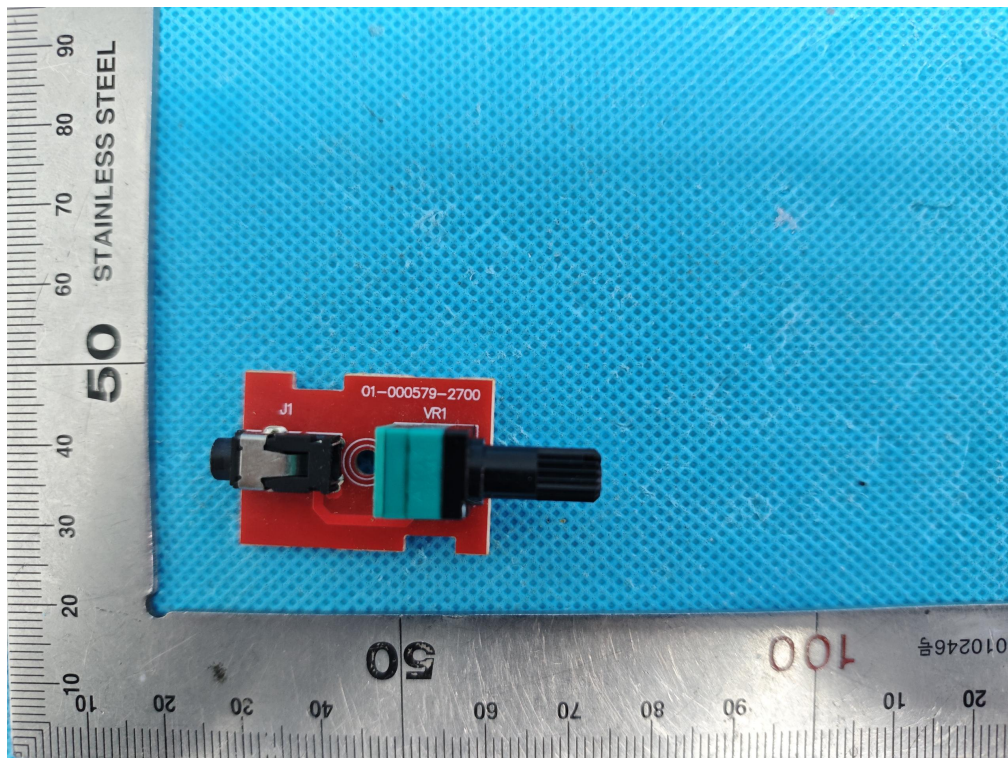


Internal view-2 of EUT

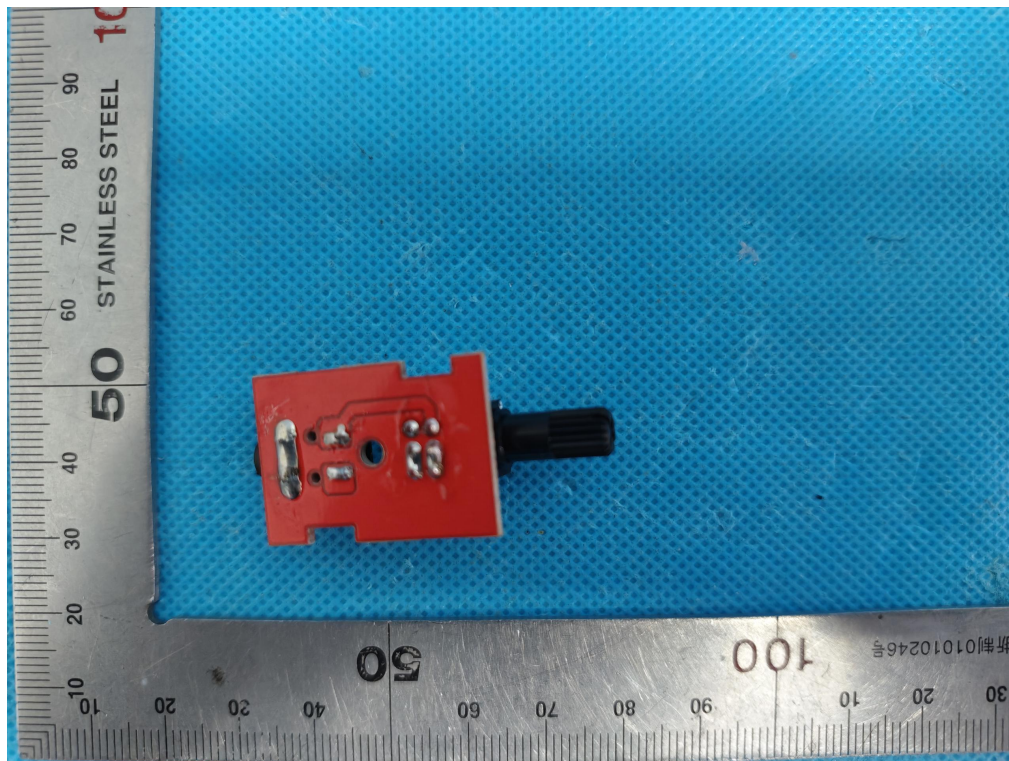


Internal view-3 of EUT
